Planned Network Change(s):

On or after December 3, 2022, Citizens Telecommunications Company of New York, Inc d/b/a Frontier Communications of New York ("Frontier") will retire the Hannibal NY DCO switch located at 327 Church Street Hannibal, NY 13074, and subtending remotes and remove them from the network after all traffic is migrated to Frontier's Earlville NY Packet End Office (PEO) switch located at 12 N Main Street Earlville, NY 13332.

- All references to the Hannibal NY DCO switch are associated with CLLI code HNBLNYXADSO will not be repeated throughout this letter.
- All references to the subtending Cato NY DCO Remote switch are associated with the CLI Code CATONYXARSO will not be repeated throughout this letter.
- All references to the subtending Fair Haven NY DCO Remote switch are associated with the CLLI Code FHNCNYXARSO will not be repeated throughout this letter.
- All references to the subtending Lysander NY DCO Remote switch are associated with the CLLI Code LYSNNYXARSO will not be repeated throughout this letter.
- All References to the Earlville NY Packet End Office (PEO) switch are associated with CLLI code ERVLNYXAPSO will not be repeated throughout this letter

Description of the Planned Network Change(s): The Exchange Codes (NXX) identified in Table B in Numbering Plan Area (NPA) 315 currently residing in the Hannibal NY DCO switch located at 327 Church Street Hannibal, NY 13074 and subtending remote switches listed in Table B below will be moved to the Earlville NY PEO virtual switch located at 12 N Main Street Earlville, NY 13332 (see details in Table A below).

The native NPA/ NXX codes assigned to the Hannibal NY DCO switch and subtending remotes will be rehomed upon decommissioning of the switch and reflected in the

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

The Earlville NY PEO switch will be the recipient office of traffic migrated from the Hannibal NY DCO switch and subtending remotes. Traffic bound for the codes listed in Table B will be delivered via the Earlville NY Tandem (ERVLNYXAO1T Intra-Lata SHA/ERVLTNXAO1T Inter-Lata FG Access SHA).

After all traffic is migrated off the Hannibal NY DCO switch and subtending remotes, they will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Earlville Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Hannibal NY DCO switch and subtending remotes will be required to reposition the codes to the Earlville Tandem switch.

All ASRs (Access Service Requests) for the Earlville Tandem switch must be received no later than **August 1, 2022** to provide sufficient time to migrate the traffic described

above. All traffic must be moved by September 1, 2022. All ASRs for the Earlville Tandem switch must carry the project code of HNBLNYXADSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Hannibal NY DCO switch and remotes.
