Description of Network Changes Planned:

Frontier Southwest, Inc. ("Frontier") announces that it intends to retire copper facilities at various locations in the wire centers listed below:

Description of Reasonably Foreseeable Impact of the Planned Changes:

Frontier has deployed fiber-to-the-premises network in this wire center and intends to provide services over a fiber network infrastructure. Updating our network from copper to fiber benefits our customers because of fiber's resiliency and reliability, especially in inclement weather. Fiber also provides our customers with expanded capabilities to grow with current bandwidth demands for their home or business.

Because of municipal road work, Frontier is being forced to migrate the seven locations to fiber within a short timeframe. Frontier will cease maintaining the copper facilities at these locations. All existing circuits will be transferred to the fiber platform once completed. Notices have been sent to the affected interconnecting entities to prepare for the migrations.

To help ensure an orderly transition, Frontier may require customers and interconnecting entities to migrate services off of copper well before the copper retirement implementation date.
