Frontier Midstates, Inc.-MI announces that it intends to retire it's Gregory DCO Switch the wire center listed below:

On or after February 28, 2024 the Gregory, MI DCO switch will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network. The Gregory switch has been failing for some time. Frontier has started to contact customers and has begun the migration. Frontier would like to migrate customers as soon as possible to ensure network reliability.

The Exchange Code (NXX) 498 in Numbering Plan Area (NPA) 734 currently residing in the Gregory, MI DCO switch (see list in Table B below) will be moved to the ADRNMIXGPSO PEO virtual switch (see details in Table A below).

Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Gregory, MI DCO switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Elkhart, IN PEO switch. This will occur on or after February 28, 2024.

Network Changes and Trunk Rearrangements:

The Adrian, MI PEO switch will be the recipient office of traffic migrated from the Gregory, MI DCO switch. Traffic bound for the codes listed in Table B will be delivered via the Adrian, MI Tandem (ADRNMIXG45T Intra-Lata SHA/ADRNMIXG45T Inter-Lata FG Access SHA).

After all traffic is migrated off the Gregory, MI DCO switch and remotes, it will be retired and removed from the network.

Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Elkhart Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Gregory, MI DCO switch and remotes will be required to reposition the codes to the Adrian, MI Tandem switch.

All ASRs (Access Service Requests) for the Adrian Tandem switch must be received no later than January 30, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by February 15, 2024. All ASRs for the Adrian Tandem switch must carry the project code of GRGRMIXIDSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Gregory, MI DCO switch.
