On or after June 1, 2024, the Giddings, TX DCO switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 979 currently residing in the Giddings, TX DCO switch and associated remotes (see list in Table B below) will be moved to the BRYNTXXAPS1 PEO virtual switch (see details in Table A below).

## **Description of Reasonably Foreseeable Impact of the Planned Changes:**

The native NPA NXX belonging to the Giddings, TX DCO switch and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Bryan, TX PEO switch. This will occur on or after June 1, 2024.

Network Changes and Trunk Rearrangements:

The Bryan, TX PEO switch will be the recipient office of traffic migrated from the Giddings, TX DCO switch and associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Bryan, TX Tandem (BRYNTXXAO2T Intra-Lata SHA/BRYNTXXAO2T Inter-Lata FG Access SHA).

After all traffic is migrated off the Giddings, TX DCO switch and remotes, it will be retired and removed from the network.

## Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Bryan Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Giddings, TX DCO switch and remotes will be required to reposition the codes to the Bryan Tandem switch.

All ASRs (Access Service Requests) for the Bryan Tandem switch must be received no later than March 15, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by April 15, 2024. All ASRs for the Bryan Tandem switch must carry the project code of GNGSTXXADSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Giddings, TX DCO switch and remotes.
