On or after July 17, 2024, the Corinth, NY DCO switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Code (NXX) in Numbering Plan Area (NPA) 518 currently residing in the Corinth, NY DCO switch and associated remotes (see list in Table B below) will be moved to the GLVVNYXAPSO PEO virtual switch (see details in Table A below).

## **Description of Reasonably Foreseeable Impact of the Planned Changes:**

The native NPA NXX belonging to the Corinth DCO switch and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Gloversville, NY PEO switch. This will occur on or after July 17, 2024.

Network Changes and Trunk Rearrangements:

The Gloversville, NY PEO switch will be the recipient office of traffic migrated from the Corinth, NY DCO switch and associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Gloversville, NY Tandem (GLVVNYXAO1T Intra-Lata SHA/ GLVVNYXAO1T Inter-Lata FG Access SHA).

After all traffic is migrated off the Corinth, NY DCO switch and remotes, it will be retired and removed from the network.

# Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Gloversville Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Corinth, NY DCO switch and remotes will be required to reposition the codes to the Gloversville Tandem switch.

All ASRs (Access Service Requests) for the Gloversville Tandem switch must be received no later than June 17, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by July 17, 2024. All ASRs for the Gloversville Tandem switch must carry the project code of CRNTNYXADSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Corinth, NY DCO switch and remotes.
