Subject:	Legal and Contract Notice of Rate Increases and Changes of Law: Discontinuance of Certain Unbundling Obligations per FCC Forbearance and Modernization Orders; and Rate Increase of 25% on UNE DSO Digital Loops
Date Effective:	March 1, 2024

This notice is further to prior communications that Frontier has made to its customers during the past several years regarding the subject matter covered herein.

Your company has previously obtained or may have planned to order and obtain unbundled network elements ("UNEs") from Frontier in the form of unbundled analog and/or digital local loops (collectively, "Loops"). Such Loops that are (or were) inservice as of the respective applicable dates set forth in the FCC Schedule (defined and set forth below) are referred to as "Embedded Base UNE Loops". Your company's purchase of Loops from Frontier is pursuant to one or more interconnection agreements between Frontier and your company, in accordance with Section 251 of the Communications Act of 1934 (47 U.S.C. §151 et seq.), as amended from time to time (including, without limitation, by the Telecommunications Act of 1996) (the "Act") (each such agreement, an "Interconnection Agreement").

Discontinuance of Certain Unbundling Obligations per the FCC Schedule. Pursuant to the Federal Communications Commission ("FCC")'s Forbearance and Modernization Orders,¹ and notwithstanding anything that may be to the contrary in any Interconnection Agreement, Frontier is not (and has not been, as applicable) obligated to provide to your company its Embedded Base UNE Loops at their previous rates or on their previous terms and conditions, or new UNE Loops at such

Per the FCC Forbearance and Modernization Orders, this contract notice, and previous notices regarding resale and UNEs, customers are (and have been) on notice of the changes of law resulting from the FCC Forbearance and Modernization Orders, associated rate increases and Frontier's intent to implement and apply those changes as of the earliest applicable date.

rates or on such terms and conditions, as of the terms and timeframes established by the FCC, as follows (such terms and timeframes, the "FCC Schedule"):²

- 1. UNE Analog Loops:
 - a. New ordering ended: February 2, 2020
 - b. Pricing regulation ended: August 2, 2022
- 2. UNE DSO Digital Loops for Urbanized Areas:
 - a. New ordering ended: February 8, 2023
 - b. Twenty-five percent (25%) price increase permitted beginning: February 8, 2024
 - c. Pricing regulation ends: February 8, 2025
- 3. UNE DS1 Digital Loops for Competitive Counties:
 - a. New ordering ended: February 8, 2023
 - b. Pricing regulation ends: August 8, 2024
- 4. UNE DS3 Digital Loops for Competitive Counties:
 - a. New ordering ended: February 8, 2021
 - b. Pricing regulation ends: February 8, 2024

The changes of law per the FCC Forbearance and Modernization Orders, including, without limitation, discontinuance of unbundling of analog and digital local Loops at unbundled local Loop rates per the FCC Schedule, are self-effectuating and do not require an amendment of any Interconnection Agreement. The FCC has provided a transition over time, pursuant to which your company has been able to plan for these changes accordingly.

Rate Increases. Rates have already increased, or will increase, for unbundled analog and digital local Loops effective as of the dates set forth in this, and prior, Frontier notices, in each case consistent with the dates and terms of the FCC Schedule. For UNE DSO digital Loops for all states in the Frontier footprint, the new rates – which reflect a twenty-five percent (25%) or, in some cases, slightly less than that, increase over existing rates, for both your DSO digital Embedded Base UNE Loops and new orders – are set forth in Attachment A to this notice and will take effect beginning on March 1, 2024. Some rate changes may be effectuated initially using a true-up to operationalize the rate increases.
