On or after October 7, 2024, the Baytown West, TX GTD5 switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Baytown West, TX GTD5 switch, and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Dickinson, TX PEO switch. This will occur on or after October 7, 2024.

Network Changes and Trunk Rearrangements:

The Dickinson, TX PEO switch will be the recipient office of traffic migrated from the Baytown West, TX GTD5 switch and Associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Dickinson, TX Tandem (DCSNTXXAO1T Intra-Lata SHA/ DCSNTXXAO1T Inter-Lata FG Access SHA).

Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Dickinson Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Baytown West, TX GTD5 switch, and remotes will be required to reposition the codes to the Dickinson Tandem switch.

All ASRs (Access Service Requests) for the Dickinson Tandem switch must be received no later than September 7, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by September 30, 2024. All ASRs for the Dickinson Tandem switch must carry the project code of BYTWTXXBDSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Baytown West, TX GTD5 switch and remotes.
