Subject: After-Hours CFA Roll/Hot Cut Requests for Access Services

Require FDT Field Population *Reminder*

Date Effective: 11/18/2013

Effective November 18, 2013, access services customers submitting an after-hours CFA Roll/Hot Cut Access Service Request (ASR) must begin populating the FDT field as Frontier will no longer accept after-hours CFA Roll/Hot Cut timeframes populated in remarks. Should an ASR be submitted for an after-hours CFA Roll/Hot Cut and the FDT field is not populated, Frontier will C/NR the request and require a supplement prior to processing the service order.

In addition, per our tariffs, Frontier will bill additional labor fees applicable for work performed on CFA Roll/Hot Cuts outside normal business hours. Normal business hours are defined as 7:00 AM to 6:00 PM (local time) Monday through Friday.
