Fiber Reservation 10- business days after CLEC receives Frontier's positive response	If CLEC has these terms in Interconnection Agreement, they can reserve available fiber for 10 business days from the time FRONTIER returns the answered Dark Fiber Inquiry until a firm order ASR is submitted to order Dark Fiber – answer yes or no depending on interconnection agreement terms	
CLEC wants FRONTIER to reserve available fiber for 10 business days	CLEC wants fiber reserved as described above – answer yes or no	
Intermediate Office Routing (IOF)	If CLEC has these terms in Interconnection Agreement, FRONTIER will provide indirect routes for dark fiber IOF circuits without collocation requirement in intermediate offices. – Answer yes or no depending on interconnection agreement terms.	
Parallel Provisioning	Parallel Provisioning essentially allows the CLEC to order and pay for Dark Fiber facilities while waiting for their Collocation arrangement(s) to be constructed.
