Dedicated Ethernet Products - Discontinuation/Grandfather of End-of Life ("EOL") Products

Purpose

The following Wireline and Wireless Dedicated Ethernet products are discontinued and grandfathered effective October 2, 2022: ¹ Ethernet Private Line (aka VzON or Frontier Ethernet Private Line) and GigaMAN.

Frontier will no longer install EOL and Grandfathered Dedicated Ethernet Products associated with contract identifiers ("Contract IDs"), also known as promotion numbers ("PNUMs"), that begin with FB, PC, VZ, EPL, or EOS. The E-Path point-to-point configuration using PNUMS that begin with EPAV will replace the EOL Products. For request of 10G or higher, the Frontier Optical Transport Service ("FOTS") PNUMS will replace the EOL products.

In-Flight Orders Under EOL Contracts

- ASRs that are pending (in-flight) on or before October 2, 2022 (VzON and GigaMAN)
 - Will be allowed to move through to completion under the EOL contracts for the initial service term.
 - Supplements will be accepted for order corrections and due date changes until the ASR is either completed or cancelled.
