Description of Network Changes Planned:

Frontier Citizens Communications of Minnesota - announces that it intends to retire its Hayfield, MN DCO Switch the wire centers listed below:

On or after February 1, 2025, the Hayfield, MN DCO Remote switch, will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) 507 in Numbering Plan Area (NPA) 477 currently residing in the BLPRMNXBDSO/HYFDMNXARSO DCO switch and associated remote (see list in Table B below) will be moved to the BLPRMNXBPSO PEO virtual switch (see details in Table A below).



Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Hayfield, MN DCO Remote switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Blooming Prairie, MN PEO switch. This will occur on or after February 1, 2025.

Network Changes and Trunk Rearrangements:

The Blooming Prairie, MN PEO switch will be the recipient office of traffic migrated from the Hayfield, MN DCO Remote switch. Traffic bound for the codes listed in Table B will be delivered via the OWATONNA. MN Tandem (OWTNMNOW12T Intra-Lata SHA/ OWTNMNOW12T inter-Lata FG Access SHA).

After all traffic is migrated off the Hayfield, MN DCO Remote switch, it will be retired and removed from the network.



Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the OWATONNA Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Blooming Prairie DCO switch and remotes will be required to reposition the codes to the OWATONNA Tandem switch.

All ASRs (Access Service Requests) for the OWATONNA Tandem switch must be received no later than December 1, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by January 1, 2025. All ASRs for the OWATONNA Tandem switch must carry the project code of **HYFDMNXARSO**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Hayfield, MN DCO remote.
