 Subject: Meet-Point Ordering Post-Divestiture of Frontier Northwest Four States
 Date Effective: On or After 04/30/2020

Frontier previously communicated that at 11:59 p.m. Eastern Time, April 30, 2020 or on a subsequent date (Close/Closing Date), assuming all required conditions are met, it will complete the process to divest its wireline assets in the Northwest Four states. Following the Closing Date, all meet-point ILEC/RBOC companies with activity to the Frontier Northwest Four state properties will begin exchanging with the acquiring company, Ziplly Fiber, using the ICSC of FV03. Ownership of the OCNs associated with the Northwest Four State properties and the ICSC FV03 will transfer to Ziplly Fiber at close. All meet-point activity for ICSC FV03 (see chart below) post-close, will be managed by Ziplly Fiber and not Frontier. New ordering contacts will be provided by Ziplly Fiber in conjunction with close.

Additionally, at close any pending ASR PONs (inflight), for the properties listed above, will be worked to completion under the submitted ICSC. After close, supplemental activity for pending ASRs in the properties listed above that were initially directed to any ICSC other

than FV03, must be directed to that same initial ICSC. Post-close, any new orders submitted for the properties listed above must be directed to ICSC FV03.

Following the completion of the divestiture of Frontier's Northwest Four States, ICSC CZ05 will remain with Frontier and will continue to be utilized for the designated properties as shown in the Frontier to the [ICSC Job Aid](#), other than the divested states.
