Purpose

The following Wavelength products were discontinued and grandfathered effective October 1, 2023: Optical Wave Service (OWS), DecaMAN Service, and WaveMAN Service products.

Frontier will no longer install grandfathered Wavelength Products associated with contract identifiers ("Contract IDs"), also known as promotion numbers ("PNUMs"), that begin with FB1, OCM, OCW, PCE, or PCF. New wavelength services will replace these grandfathered products. For new wavelength service, 10 Gbps or higher, as Frontier Optical Transport Service (FOTS) using PNUMs that begin with FOT and VEL. Switched Ethernet, E-Path point-to-point configuration using PNUM EPAV, may also be used for lower bandwidth (1 Gbps) service.



In-Flight Orders Under End of Sale (EoS) Contracts

- ASRs that are pending (in-flight) on or before October 1, 2023 (OWS, DecaMAN Service, and WaveMAN Service)
 - Will be allowed to move through to completion under the
 - contracts for the initial service term.
 - Supplements will be accepted for order corrections and due date changes until the ASR is either completed or cancelled.
