4. Test calls should be performed to each telephone number that is being used as a Remote Call Forward number. This will verify the routing of the call and if you should use 7 digits (555-1212), 10 digits (304-555-1212)		
5. Service and Equipment Code required when additional paths are requested. Example: GSZ 1 for 1 additional path/GSZ 2 for 2 additional paths) ***Note use appropriate Additional Path code per State/Tariff		
6. The listed address must be the address of the terminating number (CFN).
