LSR Validation – Rules for REQTYPs DB & EB

Objective

The objective of this document is to provide a quick reference tool for the CLECs to populate Wholesale Platform and Resale LSRs at the TOS and LTOS levels for both new (ACT=N), outside/inside move (ACT T/M) and migrate (ACT=V) orders for the following services

- POTS
- RCF

Note: This document does not include validations for Centrex, Wholesale Broadband and other complex services.

At-a-glance

This chart provides basic rules for both Wholesale Platform and Resale orders in the F13, Acquired WV, Legacy and CT environments when POTS and RCF services are ordered.

DB - Wholesale Platform	EB - Resale
Measured product only	Flat & Measured services available
3 rd position of TOS will always= M or P (Legacy only)	3 rd position of TOS must match class of service (F= Flat or M= Measured line rate)
PSQTY must match number of LNUMS on PS Form	RSQTY must match number of LNUMS on RS Form
