Place Listing As (PLA) Job Aid

General

Description

PLA is the detail needed for a publisher to place a directory listing in the correct alphabetic order. Place Listing As (PLA) can be used on a business directory listing that contains an acronym or number, telling the publisher where to position the listing within the alpha section.

Use Place Listing As when a business listing contains an acronym or number. Populating the PLA field when a listed name does not contain an acronym or number may significantly and negatively alter the placement of the listing in an illogical section of the printed directory.

The PLA field is required when a business listed name includes a number. The directory publisher uses sorting logic that translates a number into a corresponding word version of the number. This detail is provided in the *How a Number is Sorted* section of this document.

The PLA field is required on a business listing name includes two or more upper-case letters. This type of listing is considered an acronym and is placed in the directory as a word. See *PLA for Acronyms*.

Listed names that include abbreviations do not prompt PLA field population. The directory publisher uses sorting logic that translates an abbreviation into a fully spelled word. This detail is provided in the *How an Abbreviation is Sorted* section of this document.

Restrictions

Place Listing As is required when a business listing contains an acronym or number.

Note: Effective February 2014, only business listings prompt PLA field population. Residential listings are prohibited from populating the PLA field. A Directory Listing inquiry on a residential listing may return a PLA line of detail on an existing listing. However, subsequent orders on the listing will restrict continued use of the PLA field on the residential listing.

Use PLA with Caution

Use caution when populating the PLA field. The publisher uses the PLA entry to determine listing placement in the printed directory regardless if the PLA detail is contradictory to the listed name or ultimately places a listing in an alpha section unrelated to the listed name.

Common PLA Mistakes

This section contains examples of the most common Place Listing As PLA mistakes.

The PLA name conflicts with the Listed Name

What is populated in the PLA field serves to assist the publisher with positioning the listing alphabetically.

In this example the listed name Williamsburg R C is destined for the “W” section of the printed directory. The PLA indicates the listing should be printed as if it were R C Williamsburg Plumbing. The result of this placement will cause Williamsburg R C to be printed in the “R” section of the directory.

PLA name exactly matches the listed name:

In this example the LNLN and LNFN indicate the listed name is Outlandish Dishes. The PLA indicates it should be listed as....Outlandish Dishes. There is not difference between the two listings. In this case, the PLA was unnecessary.

PLA places the listed name in an illogical alpha section of the directory.

In this example the LNLN and LNFN indicate the listed name is HHH Metrodome. Because the PLA instructs the placement to be as if the listing were Metrodome Sports Arena, this listing is found in the “M” section, not “H” as one would expect.

PLA for listings with Acronyms

Sorting a Listing with an Acronym

All directory listings are organized in Alphabetic order. When two or more sequential capital letters make up part of the listed name it is considered an acronym. The default sorting rule for a listed business name containing an acronym is to consider the acronym as a single word.

Example:
Dixon Plumbing
DMC Heating
Dmitrieva Art Gallery

How to use PLA with Acronyms

The default and primary sorting method of an acronym is “word placement.” It is as if the acronym were a single word.

PLA entries should carefully reflect the listed name. correspond with the A placement option of sorting the acronym as if the *first letter* of the acronym were a word by itself is called “letter placement.” This chart provide examples of how PLA entries are treated when the listed name is an acronym.

In this chart of example entries, the listed name is DMC Heating

PLA Entry	Sorting Treatment
DMC Heating	DMC Heating is printed and sorted in the “D” section as if DMC were a single word
David Michael Connor Heating	DMC Heating is printed and sorted in the “D” section as if the listing were David Michael Connor Heating.
Heating DMC	DMC Heating is printed in the “H” section as if the listing were Heating DMC.

PLA for Listings with Numbers

Number Listing Positioning

All directory listings are organized in Alphabetic order. When a listed name includes a number, PLA is required to help the publisher position the listing. The spelled-out versions of the number(s) are written on the PLA line.

When a listed name **begins** with a number the publisher uses sorting logic to determine the alpha section in which to place the listing. This detail is provided in the *How a Number is Sorted* section of this document. Some examples are...

7 Up Beverage Company
7-11 Convenience Store

PLA Number examples

Populate the PLA field with any numbers spelled as written words. Do not include special characters in the PLA field. Use only alpha characters. Here are some samples of correct PLA field population.

Listed Name: Glass 4 Everyone
PLA example: Glass For Everyone

Listed Name: 4 Eyes Eyewear
PLA example: Four Eyes Eyewear

Listed Name: 191 School District
PLA example: One Ninety One School District

Listed Name: C3 Medical Spa
PLA example: C Three Medical Spa

Be careful that the PLA entry reflects the listed name. In this example, the PLA entry will cause the listing to be sorted in an unrelated alpha section.

Listed Name: C3 Medical Spa
PLA example: Three Rivers Medical Clinic
