TXNUM – Transaction Number	Identifies the customer provided tracking number to link the inquiry with the response.	
D/TSENT – Date/Time Sent	Identifies the date and time the transaction is sent.	
TXTYP – Transaction Type	Identifies the type of transaction	G
TXACT – Transaction Activity		
CC – Company Code	Identifies the exchange carrier initiating the transaction	
EXRESDT - Reservation Expiration Date Extension	Indicates a request to extend the expiration date associated with the original reservation	
STATE – State/Province	identifies the abbreviation for the state or province	
RESNO - Reservation or Requested Number	Indicates the reservation number provided at the time of telephone number reservation	
PRESPEC - Provider Response Code	Identifies a provider specific code on the response transaction that represents what occurred on the associated inquiry transaction	See Pre-Order Response Error Code matrix for full list
RPESPD - Provider Response Description	Identifies the provider's text used to clarify the response for the associated inquiry transaction
