Frontier Communications is providing notification that, effective February 24, 2020, a new Access Services Contract Validation Database (CVD) validates contract effectiveness on incoming ASR transactions. The CVD contains customer specific contract information and validates using specific fields on an ASR. This new process is designed to help ensure ordering and billing accuracy.

In addition, new Access Custom Business rules, as shown in the chart below, are in effect to support the CVD.

New Access Custom Business Rules

Error #	Validation	Error Message
FTRCV1001	Validates the first 8 characters of the ACTL using the PNUM	ACTL is not valid
