# AT&T Mobility CT 515 Sites (Clusters)



### **Overview**

This document is to provide guidance for the 515 CT Cluster Sites.

Guidelines:

- 1. To enhance project and cluster coordination, the ATTM Market Team will include ATTM Sales Support Team (<u>attm.sales.support.team@ftr.com</u>) on the CT NTP notification.
  - a. NTP notifications will be stored on Frontier's Marketing and Sales Resources sharepoint site.
- 2. E2E notification for the entire cluster will only be sent to ATTM when all sites within the cluster are E2E complete. New PONs should be issued after receiving the E2E notification for the entire Cluster.
- 3. All PONs received in a cluster will be held before the Due Date Task. The UNI PONs will not get a Due Date complete notification until all PONs are ready to be completed. EVC PONs should be submitted when FOC notification is received.

# **Ordering Requirements**

**PNUM:** SEW001AWLICBSCM792 **VTA:** 60 **DDD:** All UNI's and EVC's must have the same DDD within the cluster

**PROJECT FIELD:** The Project field must be populated with the associated cluster name and should coincide with the FA Code for the cluster.
