#### Overview

1. The purpose of this document is to provide ordering guidance when performing a 1G to 10G Migration for UNI's at a cellsite.

The following table is part of the CSBH schedule agreement and is subject to change.

18. Conversion of 1 Gbps to 10 Gbps and New 10 Gbps E-Path CSBH Service. Notwithstanding anything that may be to the contrary in the Agreement, 10 Gbps Service and conversions of UNIs from a 1 Gbps UNI E-Path CSBH Service(s) to an E-Path CSBH Service 10 Gbps UNI are subject to this Section 18. Provisioning of 10 Gbps at the Cell Site has not been implemented in all areas as of the date on which the Parties execute this E-Path CSBH Service Schedule. Customer has the option to request and Frontier will provide a quotation for, pursuant to Section 5, 10 Gbps Service or, if required to meet Customer's network capacity and utilization requirements, conversion of a 1 Gbps UNI E-Path CSBH Service(s) to an E-Path CSBH Service 10 Gbps UNI, at the rates contained in Exhibit A.

18.1 When ordering 10 Gbps Service and when converting UNIs from a 1 Gbps UNI E-Path CSBH Service(s) to an E-Path CSBH Service 10 Gbps UNI, Customer must first order two (2) 10 Gbps NNIs or two (2) 100 Gbps NNIs at the Service Hand-Off Location (regardless of whether, for example, an existing 10 Gbps NNI is in place).

18.2 A new 60-month Service Term will apply to the 10 Gbps UNI upon the Commencement Date.

18.3 Once a conversion pursuant to Section 18 has been completed, Customer will submit a disconnect on the 1 Gbps UNI E-Path CSBH Service and associated EVCs and applicable 1 Gbps UNI MRCs will continue to apply until such disconnect. ETL Charges shall not apply to the disconnected 1 Gbps UNI E-Path CSBH Service(s) provided that Customer populates the RPON field on the first disconnect ASR with the new install 10 Gbps UNI PON and the project field is populated with 1GTO10GCONV.

18.4 When there is more than one 1 Gbps UNI at a Customer Location and Customer submits a disconnect ASR pursuant to Section 18.1 and subsequently submits another disconnect ASR for a remaining 1 Gbps UNI at the same Customer Location, ETL Charges shall apply to the subsequently disconnected 1 Gbps UNI. Customer must leave the RPON field left blank (i.e., not populate the field) for the subsequent disconnect ASR(s).
