**Description of Network Changes Planned:**

**FRONTIER COMM OF FLORIDA** - announces that it intends to retire its GTD5 switch the wire centers listed below:

On or after March 14, 2025, the Hudson, FL GTD5 switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 727 currently residing in the Hudson, FL GTD5 switch and associated remotes (see list in Table B below) will be moved to the TAMPFLXAPS0 PEO virtual switch (see details in Table A below).



**Description of Reasonably Foreseeable Impact of the Planned Changes:**

The native NPA NXX belonging to the Hudson, FL GTD5 switch and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Tampa, FL PEO switch. This will occur on or after March 14, 2025.

**Network Changes and Trunk Rearrangements:**

The Tampa, FL PEO switch will be the recipient office of traffic migrated from the Hudson, FL GTD5 switch and Associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Tampa, FL Tandem (TAMPFLXA02T Intra-Lata SHA/ TAMPFLXA02T Inter-Lata FG Access SHA).

After all traffic is migrated off the Hudson, FL GTD5 switch and remotes, it will be retired and removed from the network.



CLECs, IXC, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Tampa Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Hudson, FL GTD5 switch and remotes will be required to reposition the codes to the Tampa Tandem switch.

All ASRs (Access Service Requests) for the Tampa Tandem switch must be received no later than February 14, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by February 28, 2025. All ASRs for the Tampa Tandem switch must carry the project code of HDSNFLXA86H.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Hudson, FL GTD5 switch and remotes.
