# **Description of Network Changes Planned:**

Citizens Telecomm Co of NY DBA Frontier Comm of NY announces that it intends to retire its DCO Host switch in the wire center listed below:

On or after November 23, 2025, the Old Forge Host switch will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Code (NXX) in Numbering Plan Area (NPA) 315 currently residing in the Old Forge, NY DCO Host switch (see list in Table B below) will be moved to the ERVLNYXARPO PEO virtual switch (see details in Table A below).

# **Description of Reasonably Foreseeable Impact of the Planned Changes:**

The native NPA NXX belonging to the Old Forge DCO Host switch and associated remotes, will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Earlville NY PEO switch. This will occur on or after November 23, 2025.

Network Changes and Trunk Rearrangements:

The **ERVLNYXAPSO** PEO switch will be the recipient office of traffic migrated from the Old Forge NY Host switch. Traffic bound for the codes listed in Table B will be delivered via the Earlville, NY Tandem (ERVLNYXAO1T Intra-Lata SHA/ ERVLNYXAO1T Inter-Lata FG Access SHA).

After all traffic is migrated off the Old Forge Host switch, it will be retired and removed from the network.

# **Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):**

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Earlville NY Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Old Forge Host switch will be required to reposition the codes to the ERVLNYXAO1T Tandem switch.

All ASRs (Access Service Requests) for the ERVLNYXA01T Tandem switch must be received no later than October 23, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by November 23, 2025. All ASRs for the ERVLNYXA01T Tandem switch must carry the project code of OLDFNYXADSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Old Forge NY Host switch.
