Description of Network Changes Planned:

FRONTIER COMM OF TEXAS – announces that it intends to retire its Stromberg Carlson DCO Switch the wire centers listed below:

On or after March 1, 2026, the Willow City, TX DCO switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 830 currently residing in the Willow City, TX DCO switch and associated remotes (see list in Table B below) will be moved to the FRBGTXAPS1 (look up on Metaswitch offering table) PEO virtual switch (see details in Table A below).



Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Willow City, TX DCO switch and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Fredericksburg, TX PEO switch. This will occur on or after March 1, 2026.

Network Changes and Trunk Rearrangements:

The Fredericksburg, TX PEO switch will be the recipient office of traffic migrated from the Willow City, TX DCO switch and Associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Fredericksburg, TX Tandem (FRBGTXXA02T Intra-Lata SHA/ FRBGTXXA02T Inter-Lata FG Access SHA). (Tandem is based on the Metaswitch the TA5K will route to, not the TDM switch)

After all traffic is migrated off the Willow City, TX DCO switch and remotes, it will be retired and removed from the network.



Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Fredericksburg Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Willow City, TX DCO switch, and remotes will be required to reposition the codes to the Fredericksburg Tandem switch.

All ASRs (Access Service Requests) for the Fredericksburg Tandem switch must be received no later than February 19, 2026, to provide sufficient time to migrate the traffic described above. All traffic must be moved by March 1, 2026. All ASRs for the Fredericksburg Tandem switch must carry the project code of WLCYTXADS0.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Willow City, TX DCO switch and remotes.
