Description of Network Changes Planned:

FRONTIER COMM OF FLORIDA - announces that it intends to retire its DMS100 switch from the wire center listed below:

Wire Center	Address	CLLI
Hyde Park, FL	105 N EDISON AVE, 33606	HYPKFLXADSO

On or after June 29, 2026, the Hyde Park, FL DMS100 switch, will be retired and removed from the Frontier network to vacate the Hyde Park central office. **Since Frontier is vacating the building entirely, we will no longer be accepting applications for new services at this location.**

The Exchange Codes (NXX) in Numbering Plan Area (NPA) **813** currently residing in the HYPKFLXADSO DMS100 switch and associated remote (see list in Table B below) will be moved to the TAMPFLXAPSO PEO virtual switch (see details in Table A below).



Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Hyde Park, FL DMS100 switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Tampa Main, FL PEO switch. This will occur on or after June 29, 2026.

Network Changes and Trunk Rearrangements:

The Tampa, FL PEO switch will be the recipient office of traffic migrated from the Hyde Park, FL DMS100 switch. Traffic bound for the codes listed in Table B will be delivered via the Tampa Main, FL Tandem (TAMPFLXA02T Intra-Lata SHA/ TAMPFLXA02T inter-Lata FG Access SHA).

After all traffic is migrated off the Hyde Park, FL switch, the switch will be retired and removed from the network **and the building/office will be closed.**



Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Tampa Main, FL Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Hyde Park, FL DMS100 switch and remotes, will be required to reposition the codes to the Tampa Main Tandem switch.

All ASRs (Access Service Requests) for the Tampa Main Tandem switch must be received no later than **May 25, 2026**, to provide sufficient time to migrate the traffic described above. All traffic must be moved by **June 8, 2026**. All ASRs for the Tampa Main Tandem switch must carry the project code of HYPKFLXADSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Hyde Park, FL DMS100.
