On or after July 13, 2026, the Matoaka, WV Remote Switching Center (RSC) will be retired and removed from the Frontier network due to damage from flash flooding in early 2025.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 304 currently residing in the MATKWVXARS3 remote switch (see list in Table B below) will be moved to the MATKWVXARPO PEO virtual switch (see details in Table A below).

Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Matoaka, WV remote switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Bluefield, WV PEO switch. This will occur on or after July 13, 2026.

Network Changes and Trunk Rearrangements:

The Bluefield, WV PEO switch will be the recipient office of traffic migrated from the Matoaka, WV RSC remote switch. Traffic bound for the codes listed in Table B will be delivered via the Bluefield, WV Tandem (BLFDWVXA13T) Intra-Lata SHA/ (BLFDWVXA13T) inter-Lata FG Access SHA).

After all traffic is migrated off the Matoaka, WV remote switch, it will be retired and removed from the network.

Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Bluefield, WV (BLFDWVXA13T) Tandem or existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Matoaka remote switch will be required to reposition the codes to the BLFDWVXA13T Tandem switch.

All ASRs (Access Service Requests) for the Bluefield (BLFDWVXA13T) Tandem switch must be received no later than April 15, 2026, to provide sufficient time to migrate the traffic described above. All traffic must be moved by May 1, 2026. All ASRs for the Bluefield (BLFDWVXA13T) Tandem switch must carry the project code of MATKWVXARS3.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Matoaka, WV remote switch.
