Grandfathering of Wireline EIA & E-Path Tier Rate Structure Promotion Numbers ("PNUMs")

Purpose

Effective March 8, 2025, the following Wireline Switched Ethernet EIA and E-Path PNUMs beginning with EIAV001 – EIAV006 and EPAV001 – EPAV006 that do not contain ICB were grandfathered.

Frontier will no longer install new services under the EIA and E-Path Tier Rate Structure PNUMs that begin with EIAV001 – EIAV006 and EPAV001 – EPAV006. When changes are required on embedded base circuits currently billing under one of these grandfathered PNUMs, follow the steps below.

Process

- ASRs that are pending (in-flight) on or before March 8, 2025 under one of the grandfathered PNUMs - Permitted
 - If an error is received, contact the ordering center at (888) 444-2267 or Carrier.DST@ftr.com
- Ordering Activity on grandfathered PNUMs
 - New installs Not permitted
 - Change to grandfathered PNUM during unexpired term
 - Ethernet Virtual Connections ("EVC") bandwidth upgrades/downgrades
 - Permitted when associated User Network Interface ("UNI") has capacity
 - Contact Account Manager when UNI does not have capacity
 - EVC Repoint Permitted
 - UNI Network Channel (NC) code optional features (position 3 & 4) –
 Permitted
 - UNI NC code (position 1 & 2) Not permitted
 - Telecom Service Priority (TSP) Permitted
 - UNI Move
 - Inside Move Permitted
 - Outside Move Not Permitted
 - EVC and UNI Disconnect Permitted (Early Term Liability applies when applicable)
 - Records
 - Circuit Reference (CKR) changes Permitted
 - Renewal at end of term
 - PNUM Permitted
 - VTA Permitted
