Before placing an order for Wholesale Advantage Broadband service, it's vital to make sure the product is available under the unique conditions for the end user. This document walks through each of the information-seeking tasks that are necessary to make a valid selection for broadband service.

This chart shows an overview of the required steps. For more detail about each step, see the *Wholesale Advantage Broadband Selection Guide* section of this document.

1.	Verify your Wholesale Broadband contract
2.	Verify the end user service territory
3.	Submit an Address Validation TXTYP A Pre-Order
4.	Submit a Loop Qualification for DSL Whls BB TXTYP X Pre-Order
5.	Verify a valid Wholesale Broadband Ordering Scenario
6.	Choose a Wholesale Broadband product
7.	Submit an LSR for Wholesale Advantage Broadband Service

Need More Help?

Additional investigative information can be obtained by submitting Loop Qualification TXTYP H and K transactions. This is especially helpful when an initial pre-order response indicates facilities are not qualified for broadband service. See the *Additional Pre-Order Transaction Options* section of this document for details.



Wholesale Advantage Broadband Selection Guide

1.	Do you have a Wholesale Broadband contract?
	Wholesale Advantage <i>Broadband</i> (WABB) contract must be established prior to order submission.
	Consult with your Account Manager to verify your contract is in place.
2.	Verify the service territory.
	 Wholesale Advantage Broadband service is available in all Frontier territories. Use the filters on the <u>Exchange and Access Line Matrix</u> located on the <u>Voice/UNE Services</u> page of the Frontier Wholesale Website to locate the applicable service territory.
3.	Submit a Pre-Order Address Validation TXTYP A
	• Exact address is important. Make sure to include Suite, Apt, etc., when applicable. Nearby addresses are returned if the submitted address is not in Frontier records. A valid address is critical



to the success of Loop Qualification pre-orders X and H.



FCI Fiber Capability Indicator Y=Yes N=No	Use the returned value to determine if fiber facilities are available
LSO Local Servicing Office	Take note of the Frontier NPANXX for the service address
Customer Data	Working service customer data, or last working service is returned, when available. • ATN = account number



	Step	Action
	1.	From the Wholesale Broadband page of the Frontier Wholesale Operations Website, open the Wholesale Broadband S&E Code Matrix for the service territory.
	2.	Identify the Product Type
		Simply or Shared
	3.	Identify the Product Speed (bandwidth)
		Choose a speed returned on the TXTYP X pre-order response. The LSA field returns the highest available speed and the HSMAX speed, separated by a hyphen. Other available speeds are provided on the pre-order response, as well.
	4.	Optional factors – Requires Pre-Order Loop Qualification TXTYP H
		 See Additional Pre-Order Transaction Options for details When FE field returns C, only copper (non-Fiber) products are available Use the returned TXTYP H LPAC field values to identify available technologies. Remember that Fiber technology can support only a Simply (Standalone) product. Shared voice service cannot be paired with Wholesale Advantage Broadband service. Use the returned TXTYP H LL field to identify products available based upon Loop Length values that are equal to or more than the LL field value (in feet)
	5.	Returned available products are shown in the Wholesale Advantage Broadband Description column.





The valid entry "DLC - LST Dependent" indicates the address is served by DLC and line station transfer (LST) availability is unknown. Qualified Copper is dependent upon successful completion of an LST.

- 2. Submit a Pre-Order Loop Qualification TXTYP K (Optional)
 - This transaction places a request for Frontier to further examine the facility qualifications for service.
 - The response is emailed to the requestor. It is important to include a valid email address on the initial pre-order transaction.
