DS3 Term Rates in effect as of November 19, 2021 may continue the existing term but will not be eligible to extend, renew, reenroll in, convert to a new term period, or in any other way continue their existing plan beyond its current expiration. At expiration of the term the service will convert to the Month to Month Rate. If at any time an existing customer terminates its DS3 Term Rates, the customer may not re-subscribe to the rate.

Effective July 26, 2022 Any DS3 Service billing at the Month to Month rate will convert to the DS3 Individual System Month to Month rate. In addition, at the expiration of a Service Period, the DS3 service will convert to the Individual System Month to Month rate.
